International Community Resolute Against Coup D'etat — Osinbajo

Vice President Yemi Osinbajo said there is a strong resolve by ECOWAS and the international community not to accept coups d'etat or any other form of unconstitutional change of government.

News Agency of Nigeria reports that

Osinbajo stated this yesterday in Accra after participating at an Extraordinary Summit of the ECOWAS Authority of Heads of State and Government.

The extraordinary meeting, in which the vice president represented President Muhammadu Buhari, was to discuss the political situation in the Republic of Mali.

Osinbajo said ECOWAS had not lost its bite as it was concerned about issues of good governance and democratic enterprise in the ECOWAS region.

He said this is the sanction against Guinea and of course, what is proposed against Mali.

"So, I think what is being done is unprecedented; in the years gone by, the African Union, then known as Organisation of African Unity, never came down heavily on coup d'etat.

"But it is evident now; there is a very strong resolve that ECOWAS, and indeed the international community, will not accept unconstitutional takeovers of government in the form of coup detat and other such

unconstitutional means of taking over governments.

"So, it is very evident that there is a very strong resolve which is why we are here today", Osinbajo said.

He expressed optimism that the efforts being made to resolve the situation in Mali would yield a positive



NDLEA Sokoto Command Arrests 149 Suspects, 1993kg Of Substances

Drug National Law Enforcement Agency, NDLEA, Zonal Commandant, Abdullahi Abdul, has said the Command arrested 149 Dugs Suspects within the year out of which 144 were males and 5 females in the area of seizure.

While breaking down all seizures amounting to 1993.068kg of different types of illicit drugs, the Commandant said that Cannabis sàtiva worth1487. 86kg, 403.634kg of psychotropic substance, 1550 grammes of Heroine and 19 grammes of Amphetamine were among the illicit drugs

intercepted by the command.

Abdul said in December last year at Bafarawa Estate bordering Mammy market, 975 kg of Cannabis Sativa was arrested in a single operation saying the investigation is still ongoing.

In the area of Counselling and Rehabilitation, he explained that a total of 98 clients were successfully counselled while 9 were rehabilitated, 8 referred and 9 currently undergoing rehabilitation.

Abdullahi Abdul said there is hardly any family that is not of a drug dependent persons Executive of National Drugs numerous to mention.

For Stabbing Lover's Husband To Death

Man In Police Net

Police Command in Ogun State has arrested a 38-yearold man for allegedly stabbing his mistress's husband to death.

The police Spokesman in the State, DSP Abimbola Oyeyemi, who disclosed this in a statement issued to newsmen in Ota, Ogun yesterday, said that the incident happened at Onipanu area of the State.

Oyeyemi explained that the suspect was arrested on Jan. 7 for allegedly stabbing one Emaka Umonko, husband to a woman with whom he was allegedly having a secret love

He said that the suspect's arrest followed a distress call received by the Divisional Police Officer, DPO, Onipanu Divisional Headquarters, CSP Bamidele Job.

Oyeyemi said that the deceased, who had been suspecting that the suspect, confronted him for having an illicit affair with his wife, adding that this led to serious fight between the two men.

"While the fight was going on, the suspect, a commercial driver, brought out a knife and used it to stab the deceased severally at his back and chest, which made him ,the deceased, to collapse.

Arrests Grandpa, Fake Security Agent Over Drug Peddling

State Command of Edo National Drug Law Enforcement Agency, NDLEA, has arrested two suspects for illicit drug peddling in the

State Commander of the agency, Mr Buba Wakawa, made the disclosure to nresmen yesterday.

Wakawa disclosed that the two suspects were a 76-yearold grandfather, and an alleged fake security agent.

According to him, the suspects were arrested on Jan. 7 and Jan. 4 in the state respectively.

"Whereas popularly septuagenarian, called old soldier, was arrested on Friday, Jan. 7, 2022, in the Egor area of the State for dealing in cannabis, the suspected fake security agent was arrested for importing drug chocolates and cookies from Canada to sell.

"The suspected fake security agent was nabbed during a controlled delivery of a consignment shipped into Nigeria through a courier company", he said.

He explained that the suspected fake security agent was arrested at his apartment in Benin on Jan. 4 by undercover operatives embedded in the courier firm, soon after the suspect signed for the consignment.

consignment, which emanated from Canada, contained a suspected Colorado brand of cannabis concealed inside chocolates and weighing 6.491 Kilos, while the drug cookies and chocolates weighed 5.566 kilos and 0.383 kilos respectively.

"All the cookies and chocolates tested positive for cannabis sativa, because the cookies were also baked with cannabis", Wakawa further said.

As prelude to its reinvigorated process an expansion of voters' access to Polling Units as well as preparations for the Continuous Voter Registration exercise, among other things have been accomplished according to INEC's reckoning.

Yakubu further noted; "As we continue to plan for the next general election, the RECs have been directed to compile and submit an inventory of all election materials in order to determine shortfalls and take early steps to ensure their adequacy and availability.

"Only a few states are still outstanding. I wish to remind the States that are yet to make their submissions to do so. This will enable us to address some of the logistics issues that have become a recurring decimal in the conduct of elections in the past. The 2023 General Election must be different from previous elections in terms of our preparations and readiness".

Speaking of the stakeholder's engagement on the proposed expansion of Voters access to Polling Units and the CVR exercises. The INEC Chairman said, "The two activities are inter-related. Our plan is to conclude the ongoing consultations and the actual work on the Polling Units in earnest so that the new locations will be made public for eligible registrants to choose where they wish to register and vote on election day".

Commenting further on planning for elections, the INEC Chairman disclosed that the commission's current Strategic Plan ,SP, and the Strategic Programme of Action ,SPA, 2017- 2021, was being reviewed to capture the period from 2022-2026.

We are impressed by the revelation by the INEC boss earlier that part of the amount required for 2023 logistics and for the purchase of all the election materials needed and also cover several bye-elections across the country had been disbursed.

We are enthralled that the commission had already received N100bn out of the required amount for the elections and it is believed in many quarters that it would not fail to justify the confidence the government has reposed in the agency by this early response. It is obvious therefore that there would be no concerns bordering on paucity of funds, given the prompt response being received by INEC.

It is time for political actors of different hues and affiliations across the country to close ranks in the interest of nationbuilding against the background of dirty politicking that had pervaded the polity in the past.

Why The Tail Wags The Dog

A wagging tail is usually found at the rear end of an excited dog, but a wagging dog in front of a static tail? Only in Nigeria, where the barrack mentality of military dictatorship has been smuggled into the unitary constitution to reduce the people to subjects and their elected local leaders to paper tigers.

What happened in Lagos last week when, without reference to the state governor, the federal Attorney-General deployed armed policemen from Abuja to a residential estate in Lagos, was unprecedented. The deployment could have led to wanton bloodshed, but the governor displayed commendable sagacity in not letting the situation get out of hand.

Chief security officer my foot! There is no greater evidence of the fraudulent nature of the 1999 constitution than the designation of governors as Chief Security Officers of their states when in actual fact, they are, at best, generals without troops. Nigerian governors are nothing but mere local prefects without any power over their own security and the security of the people they govern. That's why a police chief superintendent will defy an elected governor of a state of 20 million

Anyone still in doubt about the need for state policing must have other motives other than security of lives and property. The voices of governors Nasir el'Rufa'i and Rotimi Akeredolu, both members of the governing APC, are most strident about the need for states to have their own police to maintain law and order. But the federal government wants to continue running the country as one huge barrack with command and

control flowing from one overwhelmed central source.

Akeredolu, a Senior Advocate of Nigeria, SAN, who chairs the Southwest Governors' Forum, roundly condemned the Lagos incident as another proof of the incongruity of the current 'federal' structure where the tail wags the dog: "An arrangement, which compels the governor of a state to seek clarifications on security issues in his jurisdiction from totally extraneous bodies or persons is a sure recipe for anarchy... We, on our part, will continue to interrogate the current system, which treats elected representatives of the people as mere prefects, while appointed officeholders ride rough shod over them as Lords of the Manor."

"... If Supreme Court gives a judgement and the state disobeys, the next action is to file contempt proceedings, not resort to self-help by importing policemen from Abuja to Lagos to chase people out of their houses. That is a recipe for anarchy and Malami and fellow travellers ought to know that if indeed their interest in this matter is about public good."

The unitary system being operated in Nigeria in the name of federalism is the cause of most of the security and development problems the country has. The federal government itself is not famous for obeying court orders (ask El Zak-Zakky and others). The attorney-general's claim that he was only protecting the rule of law by trying to enforce a supreme court judgement is a fib best told to the marines. Did it not take a court order to force the federal government to declare bandits as terrorists?

The argument that state governors will misuse any security force under their power is equally fraudulent. The

greatest champion of impunity and self-help in Nigeria over the years is the federal government - and no one has suggested that we should strip the federal government of the power to control forces of coercion.

Indeed, Segun Adeniyi, frontline Nigerian journalist, author and columnist, wondered how the police authorities, who are already buffeted on many fronts, decided to add Magodo to their problems: "It ought to concern the rest of Nigerians", argues Adeniyi, "that a police force faced with widespread insecurity across the nation can draft a huge contingent to Lagos for over two weeks to enforce a doubtful mandate. Clearly, the Magodo matter has once again exposed the hollow reign of narrow interest in today's Nigeria."

Let it be restated for the umpteenth time that we have always had local police before military intrusion into our affairs. I fondly recall that during the First Republic we had federal, regional and local police. Each had its jurisdiction; all collaborated whenever necessary. The argument being made by those who feel advantaged by the current hopeless unitary system shows that they think that the federal government is a kind of overlord managing recalcitrant children.

That kind of thinking flows directly from a philosophical position of a divine right of sorts. It can be seen in how the shift from parliamentary democracy to presidential system has birthed another monster: a Kabiyesi presidency which confuses the modern concept of a president as chief executive with the monarchical, unquestionable, 'rights' of a despotic king.

Ijaw Want More From Obaseki -IYC

Ijaw Youth Council, IYC, Ijaw communities said deserve more from the Edo State Government than procurement of gunboats to enhance security in the riverine areas.

The Secretary, Western Zone, IYC, Omaghomi Olu-Derimon stated this in a statement made available to newsmen in Benin, yesterday.

Olu-Derimon, commended the governor for the enhanced security across the state, said the Ijaws desire infrastructural development in their communities.

He particularly noted that the people would have been more pleased if the funds used for the gunboats were directed to address the huge infrastructural deficit that is bedeviling the riverine communities.

He said this is particularly so as the first set of gunboats procured by government are yet to be utilized.

"It will be wrong if we say that the governor is not doing his best in terms of security as it affects the state.

"Even the blind can attest to the fact that security has improved tremendously under the leadership of our undaunted governor.

"Thanks to all security agencies and the Edo State Vigilante Network that are on ground in almost all communities in Edo State, including our riverine areas.

"Just recently, government announced that it has acquired some gunboats for the riverine areas which is mostly occupied by the Ijaws of Edo State.

"It suffice me to say that the Edo State Government bought similar boats a while ago and we are equally aware they are still very new and are yet to be fully utilized as far as we are concerned, so why buy more?

'We have cried out severally that the Ijaws are marginalized in terms of infrastructural development, political appointments and elective positions.

"Ijaws in Ovia South West cannot access Benin City because of the deplorable state of Udo Ofunama Inikorogha road.

"In the same vein, the Gelegele Ekewan barracks road which hitherto served as a major access route to the state capital is now a shadow of itself.

Group Mourns Nigerian Killed In South Africa

South Africa has again gone into mourning, following the killing of yet another Nigerian in the former apartheid enclave.

The News Agency of Nigeria reports that the death of Mr Olusola Solarin, who was killed on December 12 has raised the death tally of Nigerians in South Africa to more than 127 since 2019.

Records show that 13 Nigerians sent to their early graves in the Rainbow Nation were killed by members of the South African police.

In a statement, the Nigeria Union South Africa, NUSA, described Solarin as a brilliant, hardworking, motivator and community leader, who has fallen victim to the orgy of violence

Nigerian community in and criminality in South Africa.

> The statement, jointly signed by the President of NUSA, Mr Collins Mgbo, and Secretary-General, Nimram Longbap-Longs, described Solarin as a businessman, who had a chain of businesses, including pharmaceuticals, clothes and shoes outlets.

According to the unionists, Solarin has since been buried at Makun community in Sagamu, near Abeokuta in Ogun on January 3.

Solarin was said to have met his fate after supplying goods his customers outside Johannesburg, business capital.

He was returning to his base when he was waylaid and in an attempt to prevent his assailants to allow him to taste the

he was paid by customers, they murdered him.

In the union's condolence message to Solarin's widow named Doris, who is also the Vice-President and Head of Programmes of NUSA, the union said the Nigerian community in South Africa would miss Solarin dearly.

The union members also noted that their solace was in God, knowing fully well that Solarin had run his race and that his reward awaited him at the bosom of God.

"I have never seen a man with such a heart of gold. I havve never seen a man so hardworking that with so little he built so much for his family within a reasonable time of his life.

"Life isn't fair enough

from collecting the money fruits of his labour. I am pushed to ask: `God why' but if I do, of what benefit is it? Will he be brought back to life?" Mgbo wrote in his tribute.

Missing N4.1bn NASS **Funds: SERAP** Sues Lawan, Gbajabiamila

Says suit for public interest, transparency, accountability Inability to probe fundamental breach of oversight function

chambers of the National Assembly, to probe, and refer to appropriate anti-corruption agencies fresh allegations that N4.1bn of public money budgeted for legislators is missing, misappropriated or stolen, a frontline non-governmental organisation, Socio-Economic Rights and Accountability Project, SERAP, has filed a lawsuit against the President of the Senate, Senator Ahmad Lawan and Speaker of House of Representatives, Honourable Femi Gbajabiamila.

Hitherto, SERAP had last year sent a letter to the two leaders of the National Assembly requesting them to, "Use their good offices to urgently probe and refer to appropriate anti-corruption agencies allegations that fresh allegation of missing N4.1bn of public money".

In the suit number FHC/ABJ/ CS/1609/2021 filed at the Federal High Court in Abuja, SERAP is seeking for "An order of mandamus to direct and compel Lawan and Gbajabiamila to perform their constitutional oversight functions to promptly probe the allegations that fresh N4.1bn budgeted for the National Assembly may be missing".

AljazirahNigeria recalls that the suit was filed the publication of the annual audited report for 2016 in which the Auditor-General of the Federation raised "concerns about alleged diversion and misappropriation of public funds and sought the recovery of any missing funds".

SERAP is arguing in the suit that the legislative arm of government has "legal and constitutional duties to prevent and combat corruption, as well as promote transparency and accountability in the management of public resources".

Both chambers, it noted can only effectively perform its anti-corruption role if it can demonstrate exemplary leadership to probe the allegations of corruption and mismanagement involving the legislative body.

"Transparency and accountability in the management of public resources and wealth according to SERAP "is essential for promoting development, people's welfare and well-being, and their access

equel to failure of the both to basic public services, as well as good governance and the rule of law".

"The failure of the National Assembly to promptly and thoroughly investigate, and to refer to appropriate anti-corruption agencies the allegations documented in the annual audited report for 2016 is a fundamental breach of the oversight and public interest duties imposed on the legislative body", the group argued.

The suit filed by its lawyers Kolawole Oluwadare and Kehinde Oyewumi, reads that "Granting this application would serve the interest of justice, reduce corruption and mismanagement, as well as end impunity of perpetrators, and advance the fundamental human rights of Nigerians.

'The National Assembly has no legally justifiable reason to refuse to investigate the allegations documented by the Office of the Auditor-General of the Federation.

This suit seeks to vindicate the rule of law, the public interest, and to promote transparency and accountability. Government agencies and institutions are responsible to a court of justice for the lawfulness of what they do, and of that the court is the only judge".

The letter stated that "these fresh allegations are not part of the disclosure by the Auditor-General in the audited

reports for 2015, 2017 and 2018 that N4.4 billion of National Assembly money is missing, misappropriated or stolen".

"According to the Auditor-General report for 2016, N4,144,706,602.68 of National Assembly money is missing, diverted or stolen. The National Assembly paid some contractors N417,312,538.79 without documents. The Auditor-General wants the Clerk to the National Assembly to 'recover the amount in question from the contractors".


The two chambers "reportedly N625,000,000.00 spent through its Constitution Review Committee between March and June 2016 but without any document. The Auditor-General wants the Clerk to the National Assembly to 'recover the amount from the Committee.

"The National Assembly also reportedly spent N66,713,355.08 as 'personnel cost' but 'the payees in the Cashbook did not correspond with those in the Bank Statement'. The Auditor-General wants the irregular expenditure recovered from the officer who approved the payments.

Assembly reportedly paid N116,162,522.60 to some contractors between April and June, 2016 without any document. The National Assembly deducted N56,985,568.55 from various contract payments in respect of Withholding Tax and Value Added Tax but without any evidence of remittance."

"The National Assembly reportedly paid N126,264,320.00 as cash advances to 11 staff members between March and December 2016 to procure goods and services but failed to remit the money.

"The Senate reportedly paid N747,286,680.00 as personal advances to staff members between February and December, 2016 for various procurements and services but failed to retire the money. The Senate also deducted N118,625,057.48 as Withholding and Value Added Taxes but

failed to show any evidence of remittance to the Federal Inland Revenue Service."

Senate N109,007,179.73 from the Capital Expenditure vote but without any document".

"The House of Representatives reportedly deducted N821,564,296.48 from staff salaries but failed to remit the money to tax authorities. The House also paid N254,059,513.70 as advances to staff members to procure goods and services between January and December 2016 but failed to retire the money"

Institute for "The National Legislative Studies reportedly spent N375,867,000.00 to buy 11 motor vehicles in April 2016. But the Institute also paid the same contractor N36,610,000.00 in September 2016 under the same contract without approval".

The Institute also reportedly paid N10,927,768.80 to 7 members of staff who were redeployed from the National Assembly to provide specialized services but without details about the staff paid, and without any justification".

"The National Assembly Service Commission reportedly approved N109,995,400.00 to train some office in Dubai, United Arab Emirates but spent N127,629,600.00 as Estacode Allowances to participants, and fees for two consultants engaged for the training. The Commission also spent N9,975,000.00 as course fees for 34 officers but it also paid a consultant N4,987,500.00 for the same course fees.

"The Legislative Aides Section earned N12,274,587.77 as interest on bank accounts in a commercial bank between January and December 2016 but failed to remit the money to the Consolidated Revenue Fund".

Meanwhile, no date has been fixed for the hearing of the suit.

Recently, It, however, admitted that there was a disagreement between the executive and the legislature over the 6,576 new schemes, worth N37 billion, "smuggled" into the 2022 budget by the

13,709 Arrested Over Illegal Immigration In A Week

Around 13,709 violators of residency, labour laws and border security regulations have been arrested in various regions of the Kingdom within a week.

The arrests were made during joint field campaigns carried out by various units of security forces and the General Directorate of Passports, Jawazat, during the period from December 30, 2021 to January 5.

Those arrested included 7,118 Kingdom crossing borders. The

violators of the residency laws, about 5,015 violators of the border security regulations, and more than 1,576 violators of the labour law.

A total of 365 people were arrested while trying to cross the border into the Kingdom, of whom 45 percent were Yemeni nationals, 53 percent were Ethiopians, and two percent belonged to other nationalities while 75 people were arrested for trying to flee the security forces also arrested seven who were involved in transporting

violators and giving them shelter. The total number of violators, who are currently subject to punitive measures, accounted for more than 94,175 including more than 84,532 men and 9,643 women, while the cases of 83,226 violators were referred to their diplomatic missions to obtain travel documents for their deportation.

warned that anyone who is caught facilitating anyone to enter the Kingdom in violation of the border security regulations, or provides him transportation or shelter or any assistance or service in any way, shall be awarded a maximum jail term of 15 years, a fine of up to SR1 million, confiscation of the means of transportation, and the residence used for shelter, in addition to publicizing their names

Arabic Music Institute To Be Established In KSA

is establishing an institute to train the country's musical talent.

Bait Al-Oud seeks to be a learning center for musicians so they can get the required training in playing traditional Arabic instruments and be educated about the instruments' role in developing the region's music culture.

The oud, which dates back more than 3,000 years, is one of the oldest and most important stringed instruments in the Arab world's musical heritage and it has played a significant role through history.

The commission aims to develop the institute to be a globally recognized center, spread awareness about Arabic musical instruments, specifically the oud, and preserve the heritage of Arabic music.

"The oud is one of the most important musical stringed instruments," oud player, Hasan Iskandrani told Arab News. "It by composers in shaping their oud players.

Traditional Arabic musical instruments such as the oud, duf, rebab, and mizmar, which are used in many different celebrations in the Kingdom, have played a major role in establishing the musical culture of the country and its different forms of musical expression.

There are different types of oud - including Iraqi, Syrian, Egyptian and Turkish, and it is played in different styles across the region.

In recent decades, the Kingdom has become home to talented composers, singers, and oud players.

Many people in the Kingdom enjoy the work of Abadi Al-Jowhar, who is known as the "Octopus of the Oud."

Alongside Al-Jowhar are Talal Salamah and Aseel Abu Bakr Saleem

Saudi Arabia's Music Commission has been called the 'sultan of who, to this day, are influencing an instruments' and is usually used emerging new generation of Saudi

The oud is distinctive for being fretless and pear-shaped. It is traditionally made from lightwood, has a short neck, and is normally built with 11 strings.

Being fretless, the oud is considered a versatile instrument that gives musicians the freedom to produce more fluid notes without having to retune.

And, unlike other string instruments which typically have one large hole in the center, the oud can have up to three holes, which gives it its distinctive and mesmerising tune.

This makes it ideally suited for musicians to play the maqam, a system of melodic structure used in traditional Arabic music.

And, like other ancient musical instruments, the oud has its own fans and admirers who enjoy listening to its tunes.

But, had it not been for some great musical maestros, the legacy of the oud would have probably been lost. One cannot talk about the instrument without mentioning the legends who made it what it is today.

The oud has passed through prominent musicians, from the 'King of Oud" Fared Al-Atrache, to Marcel Khalifeh in Lebanon, Munir Bashir and Naseer Shamma in Iraq, and Mohamed Al-Qasabgi in Egypt.

There are many beliefs about where the instrument originated from. It is believed that it evolved from the Persian barbat and was used during the Kassite period and Babylon in Mesopotamia, which later made its way to Europe through North Africa.

The institute, which will be run by an elite group of musicians, also aims to be a regional hub for Saudis of all ages to learn and develop techniques to play Arabic musical instruments.

In-Person **Attendance Resumes** For Primary And Kindergarten Pupils

Ministries of Education and Health announced the resumption of inperson attendance for male and female students in the primary and kindergarten stages yesterday.

The attendance will resume for those under 12 years old, starting from Sunday 20/6/1443 AH, corresponding to January 23, AD. As it includes all students in government, private, international and foreign schools.

According to the statement, students who are unable to attend for health problems or having certain medical conditions are excluded from the decision, and to continue to pursue education through remote learning via the various platforms concerned.

The decision came as a result of the successful efforts made by Saudi Arabia and the Ministries of Education and Health and the Public Health Authority, "Weqaya" in achieving social immunity in implementing the precautionary measures protocols for the safe attendance of the intermediate and secondary levels.

The Ministry of Education confirmed the readiness of all schools to implement the health precautions and procedures approved by the Public Health Authority, noting that it is following the progress of the educational process in primary and kindergarten stages according to the flexible operational models for in-person attendance.

The Jubail-based company's net profit rose by 37 percent to SR815 million, \$217 million, compared to SR596 million a year earlier, it said in a bourse to unrealised gains on equity filing.

This was mainly driven by a 51 percent increase in sales of polypropylene, used to make packaging as well as a wide array of consumer products.

Total comprehensive income surged to SR985 million, up 56 percent year-on-year, due investment during the period.

The hike came despite some drawbacks including a decline in its stake in South Korean affiliate SK Advanced Co. and higher prices of propane and outsourced propylene, among other factors that led to an increase in expenses.

Govt Bans Tricycles, Okada Operators In Kogi

Kogi State Government has banned tricycle and motorcycle operators from operating on the highways.

Mobile courts have also been constituted to prosecute defaulters of the new order expected to take effect on Jan. 17.

In a communiqué by Mr Baron Joseph-Okwoli, the state Commissioner for Transportation on Saturday, the government said tha the restriction order must be obeyed.

"The restriction was part of far reaching decisions made after extensive stakeholders' meetings on Wednesday and Friday to address the issue of incessant accidents and the need for free flow of traffic on Kogi township roads.

"The stakeholders meeting and deliberations were in tandem with the policy of the Ministry of Transport to strategise and map out plans and programmes to ensure smooth operations by road users and safety of commuters.

"It's expected that every tricycle must be coded and branded in line with the designated area of operation before plying the highways again.

"All tricycle operators must guide against overloading, speeding and must ensure that their left sides are barricaded with iron rod to guide against any accidental fall on the road.

"Tricycle and okada riders shall ensure that both left and right side mirrors are firmly fixed.

"Tricycle and Okada operators shall also ensure that all necessary valid papers and documents are collected and produced on demand for inspection", the communique read.

Similarly, articulated long vehicles operating within the state have been directed by the government to observe minimal speed limits in driving around residential areas.

It enjoined motorists within the state to always validate their vehicles' papers to avoid arrest and fines.

He earlier visited the affected villages in company of the commissioner of police and the general officer commanding of the Nigerian Army in the state to commiserate and assess the damages done to the victims.

Governor Matawalle also visited the monarchs of Anka, Alhaji Attahiru Ahmed Anka and that of Bukkuyum, Alhaji Mohammed Usman in their separate palaces, urging them to continue to give due support as usual with a view to combat all criminal activities.

In their separate remarks, the emirs pledged unreserved support and continuous directives on their subjects for the timely report of any questionable movement and character to their village heads who will subsequently communicate to the nearest security establishment for prompt action.

In a statement yesterday in Abuja and signed by her Special Assistant on Media, Mrs Nneka Anibeze, the minister condemned the killings in Anka and Bukkuyum Local Government Areas, describing it as horrific.

She described the incident as "horrific and tragic, adding that "we are very saddened by this incessant invasion and killings by bandits and we are also worried about the displaced persons, who are fleeing in their hundreds from their

communities, especially women and children".

Besides, "we sympathise with the government and people of Zamfara in this trying period and condole with the families of the dead.

"We pray for the repose of their souls and that peace returns to the state as soon as possible".

The minister directed that relief materials be sent to

internally displaced persons in the state to cushion the effects of the sudden displacement.

According to her, more than 10,000 victims have been rendered homeless after their homes were razed by bandits while scores are still missing.

"More than 500 bandits on motorcycles reportedly attacked five villages and razed their homes after killing over 200 people", she said.

FRSC Records 413 Deaths In **Road Crashes**

Federal Road Safety Corps, FRSC, in Bauchi State said 413 people lost their lives and 2,157 others sustained injuries in road crashes in 2021, according to the Sector Commander, Mr Yusuf Abdullahi.

FRSC in its 2021 annual road traffic crashes report issued yesterday in Bauchi also said that 480 road accidents were recorded across the state within the year under review.

Abdullahi blamed the accidents to speed violations, reckless driving, wrongful overtaking overloading.

He said most of the crashes occurred at night and involved commercial vehicles passing through the state.

"No fewer than 3,586 people are involved in road crashes in 2021.

'We recorded 162 fatal and 307 serious crashes during the year under review. Speeding remained the number one source of worry for corps personnel in road safety management", he said.

The sector commander lauded the commitment of the corps to control traffic crashes resulting from speeding in 2022.

According to him, the corps will continue to monitor road usage to guard against dangerous driving among other causes of road crashes in the state.

Benue: Court Remands Herdsman For Killing Farmer

Chief Magistrate court, Markudi presided over by His Worship Vincent Kor, has ordered that 21-year-old Fulani herder, Salisu Audu, be remanded at the Makurdi correctional centre facility for the alleged murder of Igwe Agale.

The accused herder operating in Iyeche community of Igumale, in Ado Local Government Area, is charged with culpable homicide, causing death of Igwe Agale and for openly grazing with his cows on a cassava farm belonging to the deceased, contrary to the provisions of the open grazing prohibition and ranches establishment laws of Benue State.

Prosecution told the court that on December 19, 2021, one Sunday Ogale, of Iyeche community of Igumale in Ado Local Government Area, reported to the police that he and his father met the accused on their farm with his cows grazing openly and in the cause destroyed their cassava farm valued at about 1 million naira only.

Prosecution further informed the court that when Igwe Agale now late pleaded with the accused to pursue his cows away from his cassava farm, he became aggressive and in the process removed a machete and cut Igwe Agale, on his head which as a result of bleeding from the injury, felled down and died on the spot.

During police investigation, the accused was arrested and allegedly confessed committing the crime but prosecution however, opposed to the bail application of the accused on condition that investigation was still in progress and asked for adjournment.

Ruling on application, the Chief Vincent Magistrate Kor, did not take the plea of the accused for want of jurisdiction, instead ordered that the accused be remanded at the Federal Correctional Center Makurdi, and adjourned the matter to the 3rd March this year for further mention.

"And when it is getting dark in the evening, he hibernates in some secluded location and come out at midnight to perpetrate their heinous acts.

"They usually operate within the hours of 0200hrs to 0300hrs by sneaking quietly into houses through doors, windows or other penetrable openings.

"The command has been trailing the culprit and his syndicate for a short while now and he is one of the

most wanted on the list", he said.

He said that preliminary indicated investigation that the suspect stole more than 200 cell phones over the years, and sold at a minimum price of N800

Police Avert Bloody Clash Between Delta Community **Youths**

The timely intervention of a team of security personnel, led by CSP Harrison Nwabuisi, Sapele Divisional Police Officer, has saved what could have become a bloody clash between youths of Otonyasere Community and their neighbouring Abigborodo.

There had been growing tension between the two over the ownership of a forest reserve and the land where Seplat Energy Plc office is situated at Otonyasere in Sapele Local Government Area of the Delta State

It was further gathered that about four persons sustained severe injuries with a Toyota Corolla and a building belonging to Otonyasere Community destroyed during the clash.

The disputed land is currently a subject of litigation before the court and is also being resided and farmed by residents from both communities.

The clash which resulted in a heavy gridlock also had residents of Otonyasere Community fleeing their homes as youths from both communities openly brandished dangerous weapons.

The prompt intervention of CSP Harrison Nwabuisi, the Sapele DPO, supported by men of the Nigerian Army, Koko, however, saved the situation from escalating.

A source said that Otonyasere, Abigborodo Sapele – Okpe Community laid claim to the ownership of the disputed land, adding that since 1999 when the renew dispute started, developers who got land in the area for industrial and other commercial purposes were forced to pay to both Sapele-Okpe community and Otonyasere.

The source stated further that the present crisis was triggered off when "some Abigborodo youths this morning came to the land and started digging, that they want to build a house on the land, that was when youths from Otonyasere mobilised themselves and stormed the place and that was when the clash began".

According to the source, 'the DPO with his team, however, intervened and dispersed the youths with tear gas before the crisis could escalate further. Most

Edo Govt Refutes Report On Relocation Of 100 Years Hospital

State Government has disclosed that it is not relocating the over 100 years old Central Hospital but reorganizing it for better service to the people.

It also debunked fears that healthcare may become inaccessible to the poor, adding that it would explore all existing health policies and programmes that "take care of the poorest of the poor".

Speaking on the demolition of parts of the hospital which it was gathered may be turned into a park, the Commissioner for Health, Professor Obehi Akoria said with COVID-19 that has changed global narratives, Stella Obasanjo Hospital which was closed to its normal activities to strictly dispense COVID-19 treatments was being rebuilt to be restored to its original activities.

According to her, "what we are doing is this; Edo State has Edo Health Insurance Commission, Edo Health Insurance Scheme with various packages suited to the needs of various people in our heterogeneous population.

"We have stationed about ten teams right there between Stella Obasanjo and Central Hospital and as patients come, they are accessing the team because there is something called the Basic Healthcare Provision Fund which is supposed to cater for the healthcare needs of the poorest of the poor via insurance and our people are already paying for it.

"The federal government has provided some funding, the state government has its own counterpart funding and there are many mechanisms that are on ground that will take care of the health needs of different strata of the population and for the very poorest of the poor, Basic Healthcare Provision Fund ensures that they get minimum package without having to pay anything".

On the relocation of the hospital, Akoria said it is being moved to the Edo Specialist Hospital. "Recently, anybody who has been to the Central Hospital will see the state of the structure, infrastructure and service provision, so the decision to upgrade healthcare means that there has to be a lateral phased movement of services from Central Hospital to Edo Specialist Hospital.

Another victim who did not disclose his name said he boarded a tricycle from Otovwodo Junction with one passenger already inside and another came in later, adding that he came down at Afiesere Junction only to discover that his handset had been stolen.

Esther, another victim, was however lucky as attempts to dispossess her of her cash failed after struggling with the hoodlums.

According to her, she was going to Otovwodo Market to purchase some provision and foodstuffs. Esther said she entered the tricycle with two passengers already inside, one of them a lady, adding that on the way, the tricycle rider branched off the Ughelli-Patani Expressway and headed towards Aro Road.

Plateau: Monarch Died Negotiating Ransom For Colleague's Release

Late first class chief in Plateau State and Mishkam Mwagavul, Da Nelson Bakfur, died on December 28 while negotiating with kidnappers on the ransom to be paid for the release of another monarch who was kidnapped on December 26.

It was gathered at the palace of the late Mishkam Mwagavul that he was in touch with the kidnappers of Sum Pyem of Gindiri, Charles Mayo Dakat, who had demanded a ransom of N500 million.

According to a source at the palace, Bakfur had urged the kidnappers to significantly reduce the amount, insisting that they cannot mobilize N500

Unknown to him and others around, the kidnappers had a mole and informant in the palace who was reporting developments in relation to the negotiation in their hideout.

Death came via a call to the monarch after a sympathizer made a donation to the ransom project and left.

According to the source, immediately, they called the deceased and told him how much he received as donation, noting that the amount received as one donation contradicted the claim that they are not worth N500 million.

Angry, the kidnappers told the Mishkam that negotiations had collapsed, and the next line of action was to kidnap and snuff out his life without any option of fine.

At this point, the source said the Mishkam, who had heart related challenges and was billed for a routine checkup early this year, broke down and all efforts , to revive him failed.

When our correspondent visited his palace, ironically the Sum Pyem whose release was being negotiated by the late Mishkam, was the chief mourner. He was seen receiving and entertaining sympathizers who arrived in droves on condolence visit. Among the notable sympathizers were the Forum of former Speakers of the Plateau State House of Assembly led by Idi Song, Mwagavul traditional title holders led by a 2023 gubernatorial aspirant, Ambassador Bagudu Horse, Senior Advocate of Nigeria and a gubernatorial aspirant, Garba Pwul, a delegation sent by the campaign organization of another gubernatorial aspirant, Ephraim Lenka Dewa, who told Sum Pyem that the late Mishkam whom he had met in Maryland in 2008 will be missed for his "thoughtful leadership".

In the opening game between Home and Bukina Faso, Hosts, Cameroon on Sunday came from behind to defeat Burkina Faso 2-1 in the opening match of the 2021 Africa Cup of Nations, AFCON.

The Indomitable Lions conceded the first goal in the tournament when Steeve Gangare scored in the 24th minute to make history as the scorer of the first goal in the 33rd edition of the continental showpiece

Cameroon responded with two goals from the spot through their captain, Vincent Abuobakar in the 40th and 45th minutes after Gustavo Sangaro scored the first goal of the tournament for Burkina Faso in the 24th minute

Aboubakar's potential hat-trick goal in the 73rd minute was ruled out for offside after VAR check.

Aboubakar, nevertheless, made history on his own as he became the first player to score a brace in the tournament

Ko'odinetan ƙungiyar na yankin Afirka, Mista Daɓid Terunngwa ne ya bayyana haka a ƙarshen mako a Abuja. Terunguwa ya ce CCI wata ƙungiya ce mai zaman kanta ta Amurka wacce ke da manufa don ƙarfafa masu aikin sa kai na 'yan kasa su yi amfani da ikon kansu da na siyasa wajen tsara manufofin yanayi mai inganci.

Terunngwa ya bayyana kuɗin carbon da rabo ko samun kuɗin shiga a matsayin tsarin da aka tsara don rage hayaƙi mai gurbata yanayi don magance ɗumamar yanayi.

Ya ce kuɗin Carbon da Rarrabawa wani tsari ne na manufofin da CCL ta ƙirƙira don sanya kuɗaɗen iskar gas ɗin da ake kashewa, ya ƙara da cewa CCL tana ba mutane damar yin aiki tare kan manufofin yanayi. Ko'odinetan na CCL ya ce kamata ya yi gwamnati ta yi la'akari da yadda za a daidaita manufofin da za a haɗa da kuɗin Carbon da kuma rabon kuɗin shiga, inda ya ƙara da cewa hakan zai sa manufar ta fi dacewa.

Terunngwa ya ce a halin yanzu manufar kuɗin Carbon da Rarraba tana aiki a Kanada, kuma tana iya taimakawa shirin Gwamnatin Tarayya na fitar da mutane miliyan 100 daga ƙangin talauci a cikin shekaru 10.

Ya ce manufar kuma za ta taimaka wa Nijeriya ta sake ginuwa bayan cutar Korona. Ko'odinetan ya ba da rahoton cewa Gwamnatin Tarayya ta bakin Ministar Kuɗi, Kasafin Kuɗi da Tsare-tsare ta Kasa, Zainab Ahmed, ta bayyana wani shiri na cire tallafin man fetur akan Motar Man Fetur (PMS), a shekarar 2022. "Gwamnatin Tarayya za ta ba da Naira 5,000. zuwa 30 zuwa

Miliyan 40 mafi talauci a Nijeriya don rage mummunan tasirin cire tallafin ga masu rauni a ƙasa kashi 40 cikin 100 na al'ummar ƙasar," in ji shi.

Ya ce manufar ita ce matakin farko na rage yiwuwar sauyin yanayi daga ɗumamar yanayi tare da ƙarfafawa talakawa ƙarfin gwiwa ta hanyar samun kuɗin shiga na yanayi. Ya ƙara da cewa manufar tana aiki ne ta hanyar sanya farashi akai-akai akan Carbon Dioɗide, CO2, abun ciki na mai.

"Domin shigar da farashin carbon a cikin Nijeriya, za mu iya farawa da farashin farko na Naira 50,000 akan abubuwan CO2 na albarkatun mai. "Haka zuwa Naira 75, 000/ton/ duk shekara ana sakawa sama a inda ake haƙo su kuma ana tarawa idan sun shigo cikin tattalin arzikin. "Kuɗaɗen shiga daga kuɗin carbon zai kuma mayar wa gidaje. Ana gudanar da kuɗaɗe shiga daga kuɗin carbon a cikin Asusun Tallafin Kuɗin Carbon kuma ana mayar da su kai tsaye ga gidaje a matsayin rabon wata-wata, " in ji shi. Terunngwa ya ce, galibin gidaje za su samu fiye da yadda suke biya na ƙarin kuɗin makamashi, ya ƙara da cewa hakan zai sa biliyoyin kuɗi a cikin tattalin arziki da kuma kare kasafin iyali haɓaka ƙirƙira da gina jimillar bukatun samfuran karancin carbon a matakin mabuƙaci.

Jami'in gudanarwa na CCL ya ce baya ga fa'idojin tattalin arziki, Kuɗin Carbon da Diɓidend suna da babban shigo da kayayyaki ga yanayin. "Bugu da ƙari, Nijeriya ma tana samun ci gaba ta fuskar shigo da kuɗaɗe da ake shigo da su daga ƙasashen waje ba tare da biyan kuɗin Carbon ba, tare da rangwame ga masana'antun Nijeriya da ke fitar da su ƙasashen, za su daƙile harkokin kasuwanci.

"Zai iya hana irin waɗannan kasuwancin ƙaura, inda za su iya fitar da ƙarin CO2 tare da zaburar da sauran ƙasashe su ɗauki irin wannan manufofin farashin carbon," in ji shi. Terunngwa ya ce a irin wannan yanayin, kamfanonin da ke neman tserewa daga hauhawar farashin makamashi za a hana su ƙaura zuwa ƙasashen da ba su yarda da su ba saboda kayayyakinsu za a biya su kuɗin shigo da su.

"Mafi mahimmanci, Kuɗin Carbon da Rarrabawa ba ya ƙara girman gwamnati kuma yana buƙatar sabbin ma'aikatun gwamnati ko ƙara kuɗaɗe shiga na gwamnati kai tsaye. "Rabon yana ƙara samar da kuɗin shiga na gaske, yana kare yanke shawar kashe kuɗi kuma zai ɗauki aiki mai ɗorewa. "Daga dukkan alamu, farashin carbon ra'ayi ne wanda lokaci ya yi kuma ba za a iya barin Nijeriya ba," in ji shi.

A cewar Terunngwa, manufar Kuɗin Carbon da Rarrabawa yana da kyau a cikin sauƙi, a bayyane yake cikin damarsa ga binciken jama'a, kuma bayyananne a cikin sigina da fa'idodinsa.

"Abin farin ciki ne cewa shirin Gwamnatin Tarayya na cire tallafin man fetur gaba ɗaya kan PMS nan da tsakiyar 2022, ya ba Nijeriya dama mai kyau da ta runguma tare da aiwatar da manufofin kuɗin Carbon da Raba shi. "A ƙarshe, ra'ayi na ne cewa idan aka yi la'akari da wannan matakin, zai zama nasara ga ƙasarmu abar ƙauna," in ii shi.

Mali Crisis

West African Leaders To Discuss Mali Crisis In Key Summit

West African leaders gathered yesterday to discuss Mali's political crisis, with the military junta submitting a new timeframe for a transition back to civilian rule at the last minute after its first proposal was rejected.

The extraordinary summit of the Economic Community of West African States, ECOWAS, bloc in Ghana's capital, Accra is expected to discuss possible sanctions on the Sahel state over potentially delayed elections, among other issues.

The meeting comes after months of increasing tensions over the timetable for restoring civilian rule in Mali after a military takeover in 2020.

In August that year, army officers led by Colonel Assimi Goita toppled the elected president, Ibrahim Boubacar Keita amid street protests against his unpopular rule.

Under threat of sanctions, Goita subsequently promised to restore civilian rule in February 2022 after holding presidential and legislative elections.

But he staged a de facto second coup in May 2021, forcing out an interim civilian government.

move disrupted the reform timetable, and was met widespread diplomatic with condemnation.

ECOWAS insisted that Mali hold elections in February.

But the government then said it would only set an election date after holding a nationwide conference -arguing that a peaceful vote was more important than speed.

Swathes of Mali lie outside of state control, with the government struggling to quell a jihadist insurgency that has raged since 2012.

On December 30, after Mali's reform conference ended, the government suggested a transition period of between six months and five years, starting from January 1,

This would enable the authorities to "carry out structural institutional reforms and, organize, credible, fair and transparent elections", it said.

But ECOWAS mediator Goodluck Jonathan asked the regime to revise that plan during a visit last week, Mali's foreign minister said.

On Saturday, the junta submitted a new proposed timetable to the bloc's acting president, Malian state

television reported -- without giving as it seeks to uphold fundamental any details about its contents.

the Meanwhile, 15-nation ECOWAS has led the push for Mali to uphold its commitment to stage elections early this year.

The return to civilian rule has put the bloc's credibility on the line principles of governance and contain regional instability.

At a summit on December 12, its leaders reiterated demands that the elections be held by February 27 as initially planned.

They maintained sanctions such as

asset freezes and travel bans within the ECOWAS region against around 150 junta figures and their families, and threatened further "economic and financial" measures.

The possibility of fresh sanctions is expected to be on the agenda at Sunday's summit.

Mauritania: Ancient Manuscripts Attract Tourists To Historic Desert City

Deep in the Sahara Desert, in the North West African nation of Mauritania, lies the oasis city of Chinguetti.

Founded in the 11th century, the city stood at the cross roads of the old trans-Saharan trade routes.

This desert is famous for its camel caravans, which in their heyday transported goods across North Africa.

Along with commerce, manuscripts from the Arab world were traded here, making Chinguetti a centre of

Cultural and social development took place around this trade, most significantly a large collection of manuscripts originating Mauritania and across the Middle mathematics,

Today the trans-Saharan trade routes of old are no more, and the desert is doing its best to reclaim this

And the manuscripts, which are part of the town and Mauritania's rich cultural heritage, are under threat from the elements.

Saif Ahmed Mamoud is the proprietor of the Ahmed Mamoud family library.

The collection began in 1699, and comprises over 700 manuscripts

This rich literary cultural heritage originates from around the Arab world. the manuscripts covering from subjects as diverse as religion,

astronomy.

"Chinguetti has many books, many manuscripts, the most important thing about these books is the most religious part of the manuscripts," he explains.

US Ready To Talk Missiles, Military Exercises With Russia — Official

United States of America is ready to discuss with Russia on missile systems and military exercises, in talks that could begin in Geneva, a senior White House official said on Saturday.

US and Russian diplomats are meeting in Switzerland to try to defuse tensions Washington and Europe accuse Moscow of preparing a new invasion of its neighbor Ukraine.

"There are some areas... where we think it might be possible to make progress," provided any promises are "reciprocal," the official said, giving some details on a conference call.

"Russia has said it feels threatened by the prospect of offensive missile systems being placed in Ukraine... The United States has no intention of doing that. So this is one area where we may be able to reach an understanding if Russia is willing to make a reciprocal commitment," said the official, who requested anonymity.

Moscow "has also expressed an interest in discussing the future of certain missile systems in Europe, along the lines of the INF Treaty (Intermediate-Range Nuclear Forces Treaty)" and "we're open to discussing this," the official said.

Finally, Washington was ready to discuss the possibility of reciprocal restrictions on the size and scope of military exercises conducted by Russia as well as by the US and NATO, the source

"We won't know until we get to these conversations starting tomorrow night whether Russia is prepared to negotiate seriously and in good faith," the official warned, saying the Russians and Americans would likely have an "initial conversation" on Sunday night before holding their "main meeting" on Monday.

"We're going into these meetings with a sense of realism, not a sense of optimism," the source said, indicating that they would be "exploratory" and would not lead to firm promises.

"I would not at all be surprised that Russian media begins to report perhaps even while the talks are still underway,

that the US has made all manner of concessions to Russia. This is a deliberate attempt to create division among allies, in part by manipulating all of you", the official told reporters on the conference call.



How COVID-19 Changed Education Sector's Narrative In 2021

In 2021, COVID-19 brought many changes into the country and the education sector was not left out.

Pupils/students from primary to tertiary institutions were forced to learn from home due to the pandemic as they adopted digital teaching and learning, which changed the narrative for the sector.

This necessitated the federal government to come up with some initiatives that encouraged students at all levels to have access to digital devices such as computers, laptops and some e-learning websites.

The launching of a free e-learning website known as inspire.education.gov.ng for all levels of education to allow for easy learning access by the Federal Ministry of Education is a good

A public affairs analyst and social advocate, Mr Carl Umegboro, in evaluating the education sector in 2021, commended some of the innovations adopted due to the COVID-19

According to him, the innovations by the Federal Ministry of Education are capable of changing the narratives in the sector in the future, if consolidated.

The approval of new universities by the National Universities Commission, NUC, to accommodate the growing population of youths seeking to be admitted into tertiary institutions was another high point in 2021.

"This intervention will go a long way to accommodate the high population of people willing to advance their education and this will reduce the usual frustration being faced by prospective undergraduates.

Frustrated students and unfortunately resort to bribery and lobbying for admission because of the difficulties in being admitted into higher institutions", he

Another achievement was the call for the harmonization of the Industrial Training Fund, ITF, with the National Directorate of Employment, NDE, for effective skills development in the country.

Stakeholders lauded the move, saying it would enable participants gain better insight into skills acquisition and be able to have the much needed support for their start-ups.

The Minister of State for Education, Mr

Chukuemeka Nwajiuba said the harmonization would not only produce proficient and employable youths, but could also produce youths with capacity to provide employment for others.

'The signing of a memorandum of understanding between the Federal Ministry of Education and other federal ministries on Technical and Vocational Education and Training, TVET, for quality skill acquisitions that will enhance youth employment is also a remarkable attainment.

"If the policy is robustly promoted and sustained, it will lead to radical national development through accelerated human capital development by providing lifelong learning opportunities for youths as practiced in many developed nations of the world".

In 2021, plans were also underway to begin a Teachers Exchange Programme with the Federal Ministry of Communication and Digital Economy to develop the digital literacy capacity of teachers in the country.

Nwajiuba said the Federal Ministry of Education was working out details with the Federal Ministry of Communication and Digital Economy to use digital bridge institutes across the six geo-political zones to enhance the computer knowledge of teachers.

In view of this, he said the Teachers Registration Council of Nigeria, TRCN, had been mandated to work with the Nigerian Union of Teachers, NUT, to activate the One Teacher, One Computer programme for effective e-teaching and e-learning.

As a result, he said the Federal Ministry of Education was enabling laptop vendors to sell to teachers and put arrangement in place for them to pay in installments within two to four

the ministry of communication and digital economy to do exchange programmes with teachers to use the digital bridge institutes that had already been built by the Federal Ministry of Communication and we are still working on the details.

"The Federal Ministry of Education will enable laptop vendors to vend to teachers and we will give them a period of two to four years to complete the payment.
"We have finished carrying out interviews for

the vendors; we just want the NUT and TRCN to conclude arrangements", he said.

The Executive Secretary, National Board for Technical Education, NBTE, Professor Idris Bugaje, also commended the harmonization of ITF and NDE for effective skills development in the country.

He said both bodies had duplicating functions that did not allow them to focus on the mandates they were set up for.

He called for an urgent introduction of apprenticeship training under the Nigeria Skills Qualification Framework, NSOF, from technical colleges.

"The ITF and NDE are duplicating functions and are losing focus from their original mandates".

Another issue during the year under review was the way that the Academic Staff Union of Universities, ASUU, and the federal government tackled the demands of the union to prevent strikes and this was a positive development.

The National President, National Association of Nigerian Students, NANS, Mr Sunday Asefon called on the federal government to intensify actions toward meeting the demands of ASUU without resorting to industrial actions.

Asefon, who said there was the need for a common ground to avoid strikes, pleaded with ASUU to also consider the interest of students at the centre of their negotiations.

"You will recall that the last industrial action embarked upon by ASUU remains the longest in the history of tertiary education in Nigeria.

"Since the inception of this democratic dispensation in 1999, ASUU has gone on accumulated strike for over five years.

"This development is not only worrisome, but portends great danger to the education sector, national development, research, and security in Nigeria", he said.

Another issue that was brought to the front

burner in 2021 was the repositioning and appropriate budgeting for the sector.

Stakeholders decried the paltry 5.6 percent budgeted for the sector in 2021, saying that such a low budget was incapable of repositioning the sector.

However, in 2022, a budget of N1.29 trillion (7.7 percent) was allocated to the sector, again falling short of the expectations of stakeholders

The National Moderator, Civil Society Action Coalition on Education for All, CSACEFA, Mr Babatunde Omole called for stakeholders' partnership with key state actors toward repositioning the education sector.

Omole said it was not only important to clamour for 20 percent allocation to education, but it is paramount to look inward to ensure that the little allocated is used judiciously.

"Education is not something that we converge and talk about extensively without taking it seriously.

"There is no way we can do this if we do not reposition ourselves as key players to move the nation's educational sector forward.

"We are clamouring for 20 percent allocation of the budget to education but we need to look inward on how we are guiding state actors to ensure that the little allocated are extensively used.

"We need to refocus on our outcome and impact positively. It does not matter the huge amount invested into education, what matters is how impactful the amount will be", he said.

Omole said that there is the need to begin to consider the challenges in terms of education resources to meet indicators of global education.

Similarly, the Country Director, ActionAid Nigeria, Mrs Ene Obi, said the future of Nigeria lies in the quality of its education, saying it is a major driver of socio-economic development.

Obi, however, called for increased domestic financing for a strong public, inclusive and resilient education system in Nigeria.

She pleaded with the federal government to rise to the challenge of increased insecurity, especially as it concerns educational institutions across the country.

On infrastructure, the Chairman, Senate Committee on Tertiary Institutions and TETFund, Ahmed Kaita, reaffirmed the commitment of using legislation with the aim of improving and rejuvenating the deployment of infrastructure in educational institutions.

Oil Closes The Week Gaining 5% Despite Friday's Price Drop

Black liquid ended the week very bullish despite Friday's dip where longs in the market took some profit after four days of bullish momentum. The week concluded is still a big one for oil bulls due to the Organization of Petroleum Exporting Countries and its allies ,OPEC+, decision to raise output in a market still battling with the impact of the Omicron COVID-19 variant.

Other factors weighing in on price are the supply concerns from the unrest in Kazakhstan, the outages in Libya and Friday's U.S. jobs report that missed expectations and its potential impact on Federal

The global benchmark, the Brent crude oil, ended the week gaining 5.2% to currently trade \$81.75 a barrel, while the U.S. benchmark, the West Texas Intermediate, WTI, crude ended the week gaining 5%, to currently trade \$78.90 a barrel. Both benchmarks are at their highest levels since late November 2021.

In Kazakhstan's main city Almaty, security forces appeared to be in control of the streets and the president stated that constitutional order had mostly been restored, a day after Russia sent troops to put down an uprising.

Production in Libya has dropped to 729,000 barrels per day from a high of 1.3 million bpd last year, partly due to pipeline maintenance work. A barrel of oil for delivery in March was selling at a discount of as much as 70 cents to a barrel for delivery in February, the highest since November.

Another factor affecting oil prices this week is an underwhelming U.S. jobs report for December, with just 199,000 positions being added versus expectations for 450,000. However, the U.S. is near the Federal Reserve's definition of "maximum employment" with a jobless rate just shy of 4%.

As previously mentioned, global producer alliance OPEC+ was also keeping a tight leash on output

for February, a trend it has kept to since August. Supply additions from the cartel are not keeping up with demand growth, as demand for crude returned to pre-pandemic levels.

OPEC's output in December rose by 70,000 bpd from the previous month, versus the 253,000 bpd increase allowed under the OPEC+ supply deal which restored output slashed in 2020 when demand collapsed under COVID-19 lockdowns.

EÎA data reveals that crude inventories in the United States, the world's top consumer, have fallen for six consecutive weeks by the end of the year to their lowest since September. This is expected to decline further as extreme frigid weather in North Dakota and Alberta is expected to hurt production in the region and lead operators to shut the 590,000 bpd Keystone Pipeline for a short period of time earlier in the week.

Nigeria Labour Congress, NLC has asked the Federal Government to halt its plans to reintroduce excise tax on locally produced nonalcoholic and carbonated

This is as the labour union has warned that the beverage sub-sector will be losing sales revenue of about N1.9 trillion as well as Company Income Tax, VAT and Tertiary Education Tax of N197 billion as against the total projected receipts of N81 billion to government.

disclosure was contained in a statement signed by the NLC President, Mr Ayuba Wabba, on Friday in Abuja, which was made available to newmen.

NLC, who asked the National Assembly to amend the urgently sections of the Finance Act which re-introduced excise duties on non-alcoholic and carbonated drinks, said that implementing the increased taxes will impose more hardship on Nigerians as well as possibly lead to loss of 1.5 million jobs.

It cautioned the federal government not to allow the current situation to degenerate into a breakdown in industrial relations in the sector and generally in the country, noting that the food and beverage sub-sector has generated the coffers of government N202 billion as VAT in the past 5 years.

The statement from NLC partly reads: "On the 31st of December 2021, President Muhammadu Buhari signed into law the Finance Act. Some of the provisions of the Finance Act include the imposition of excise duties on locally produced nonalcoholic, carbonated, and sugary drinks.

The reason offered by the government for this decision was to discourage the consumption of sugar by Nigerians as it has led to an upsurge in obesity and diabetes. In a letter dated November 27,2021, the Nigeria Labour Congress wrote to the President and Commander-in-Chief of the Armed Forces of Nigeria, President Muhammadu Buhari, GCFR and the leadership of the two chambers of the National Assembly pleading that government should suspend implementation of the excise duties on nonalcoholic, carbonated and sugary drinks.

The Congress provided a number of very cogent

not go ahead with the decision to impose fresh taxes on soft drinks. One of the reasons was that the re-introduction of excise duties on non-alcoholic, carbonated and sugary drinks will impose immense hardship on ordinary Nigerians who easily keep hunger at bay with a bottle of soft drink and maybe a loaf of bread.

"Our concern is the mass hunger that would result from the slightest increase in the retail price of soft drinks owing to the imposition of excise duties as it would be priced beyond the reach of many Nigerians. Congress was also alerted by the of soft drinks in Nigeria that the re-introduction of excise duties would lead to very sharp decline in sales, forced reduction in production capacity, and a certain roll back in investments with the certainty of job losses and possibly shut down of manufacturing plants.

"With 38% of the entire manufacturing output in Nigeria and 22.5% share representation of the entire manufacturing sector in Nigeria, the food and beverage industry is the largest industrial sub-sector in our country. The food and beverage sub-sector has generated to the coffers of government N202 billion as VAT in the past five years,

reasons government should N7.3 billion as Corporate Social Responsibility and has created 1.5 million decent jobs both directly

and indirectly. "The appeal to rescind the re-introduction of excise duties on non-alcoholic drinks becomes even more compelling when the projected immediate revenue expected from the policy is weighed against the potential long-term loss to both manufacturers and government. The beverage sub-sector will lose 40% of its current sales revenue.

"This translates to a loss of N1.9 trillion. While the government will only make a total projected receipt of N81 billion from the proposed reintroduction complaint of manufacturers of the excise duty. Government also stands to lose N197 billion in VAT. Company Income Tax and Tertiary Education Tax as a consequence of expected downturn in overall industry performance should the excise duties be effected as being planned.

"In light of the foregoing, we ask the National Assembly to quickly amend the sections of the Finance Act that re-introduced excise duties on nonalcoholic and carbonated drinks. We also ask the government to extend COVID-19 palliatives and support incentives to the Food and Beverages industry to cushion the shock and haemorrhage that the industry is trying to recover from.

"Finally, we demand that the government should engage employers in the subsector and Organized Labour in sincere discussions on other options that can deliver a mutually satisfying winwin solution to this issue. We hope that the current situation will not be allowed to degenerate into a breakdown in industrial relations in the sector and generally in the country".

Recall that a few days ago, during the public presentation and breakdown of the 2022 budget, the Minister of Finance, Budget and National Planning, Zainab Ahmed, announced the introduction of excise duty of N10 per litre on all nonalcoholic, carbonated and sweetened beverages in the country.

The charge is part of a new policy introduced in the Finance Act which was signed into law by President Muhammadu Buhari on December 31, 2021, alongside the 2022 Appropriation Bill.

In a similar move, the Manufacturers Association of Nigeria has called on the FG to halt the planned N10 per litre tax on sweetened and nonalcoholic beverages, Sugar Tax, which was proposed by the Finance Minister as part of its recent Domestic Revenue Mobilisation.

The Finance Minister in her presentation earlier this week stated that the purpose of the new 'Sugar Tax' introduced is to raise excise duties and revenues for health-related and other critical expenditures, in line with the 2022 Budget's priorities.

Ajayi-Kadir said, "The revenue aspirations of the government in introducing the excise may not be justified in the long run".

"It will raise production costs, which in turn adversely affect production levels and intimately result in dwindling profits", he added.

The Minister of Finance added that the excise duty N10/litre imposed all non-alcoholic, carbonated and sweetened beverages is to "discourage excessive consumption of sugar in beverages which contributes to diabetes, obesity".

Recall that AljazirahNigeria had reported that investors on the Nigerian Stock Exchange are to pay a Capital Gains Tax of 10% on the sale of shares according to provisions of the signed Finance Act 2021. The tax is applicable on the disposal of shares worth N100 million and above.

Buhari Blames Budget Changes By NASS To Constituency **Projects**

President Muhammad Buhari has expressed satisfaction with his relationship with the country's legislature despite the strong reservations expressed about the changes made to the document by the lawmakers.

He said that he is enormously lucky to have his party members as the majority in the parliament, adding that, that alone is enough reason to make him feel comfortable whenever he sends something to them for consideration.

President Buhari said that most changes made were constituency concerns and were made by the legislature to remain relevant in their respective constituencies.

"I think it is understandable that leaders committee insist that their constituencies must see them being effective by taking projects to them at whoever's expense. But we look at things globally. Nigeria for example, we are trying to get the infrastructure; road, rail, and power. Now, if we vote a lot of resources towards them, it will be at the expense of some village roads where people will go to their markets and so on. But what bothers them is their immediate requests, not the national level", the president said.

He advised the legislature to be less constituency-conscious and be national in budget consideration, adding that no part of the country will be denied the necessary infrastructural projects.

Appraising AfCFTA One Year After Inauguration



On the 1st of January 2021, continental trade between African countries took a very significant leap with the official commencement of the African Continental Free Trade Area Agreement, AfCFTA. An initiative that had been in the pipeline since 2012, the efforts towards making it a reality spanned five years of negotiations and other logistics planning.

The African Continental Free Trade Area ,AfCFTA, was finally formed on March 21, 2018, after 44 African countries signed the pact at an AU extraordinary summit in Kigali, Rwanda. Shortly after, 10 more countries, including Nigeria, added their signatures, and the operational phase of the AfCFTA was marked to kick off by mid-2020. However, the COVID -19 pandemic threw a cog in these projections, leading to a delay in starting operations until January 1, 2021, when the AfCFTA officially kicked off.

According to the UN Conference on Trade and Development – UNCTAD's Economic Development in Africa Report 2021, the total untapped export potential of intra-African trade is around \$21.9 billion, equivalent to 43% of intra-African exports (yearly average for 2015-2019), with an additional \$9.2 billion projected through partial tariff liberalization under the AfCFTA over the next five years. This statistic highlights the ultra-low level of intra-African trade when compared with that of countries in other continents, and in particular reflects Africa's unenviable position as an exporter of raw materials to the rest of the world.

On an individual level, African countries have not been able to scale up their economic activities due to a variety of reasons, hence the need for a deeply integrated and outwardly united front from which to achieve the cohesion needed to boost the scale of economic activity in Africa and in turn

foster development. This considered, the AfCFTA on inception was aimed at creating the world's largest free trade area; one that integrates 1.3 billion people across 54 countries, with the objective of tapping into a combined GDP of over \$3 trillion.

One year after the launch of the AfCFTA, there is the feeling that the initiative has been one large question mark so far, as trade restrictions between African countries While abound. there has been much speculation about the level of the effects of the pandemic on the AfCFTA's integration goals, the lethargic reactions of African leaders towards opening up their borders and liberalizing trade leaves much to be desired. Broadly, there have been three major bottlenecks against the working success of the AfCFTA since its inauguration:

Unwillingness to ratify all the articles of the agreements and the neverending negotiations on the rules of origin which is the intersection between trade and possible trade policy. Many African countries are still holding out on ratifying some of the phases of the AfCFTA. These countries, who make most of their revenue from exports to non-African countries, are not convinced of the benefits that the AfCFTA can add to their economy.

Lack of information about the AfCFTA

and the ways to take advantage of it by African businesses. With many countries favouring policies protectionist in their African trade outlook, there has been a dearth of information about the AfCFTA and how it can help African trade. For example, a survey of Nigerian businesses conducted by the Centre for the Study of the Economies of Africa ,CSEA, shows that over 60% of Nigeria's businesses are unaware of the recently signed AfCFTA agreement and the promises it holds for their business Even with potential benefits for firms, there are information costs reflected in different levels of awareness. Firms that don't know AfCFTA exists are unable to take advantage of the tariff arrangements or even benefit from the policy. Until businesses are aware, the costs of trading under AfCFTA will remain high.

A chronic lack of customs infrastructure and policy to be able complement the AfCFTA's customs and tariff obligations, only three countries in the AfCFTA so far have infrastructural and systemic customs capabilities on par with AfCFTA benchmarks, as well as a lack of capacity in the AfCFTA's Secretariat to push the integration agenda, given its launch in the middle of the pandemic.

Therefore, despite the AfCFTA's projection of negotiations for all three phases of ratifying the AfCFTA ,trade in goods and services, intellectual property rights, investment and competition policy, and e-commerce, being finalized by the end of 2021, there are still many loopholes in negotiations that have so far not been finalized among member countries. This has thrown a significant cog in the chances of the AfCFTA's success in 2021 as there is still a feeling of uncertainty concerning where countries stand on the agreement, an uncertainty that has affected AfCFTA trading proper.

Private sector involvement in AfCFTA

While member states have

dilly-dallied concerning embracing the AfCFTA and its trade freedoms, some private sector players have applied themselves to integrating African trade with gusto. With startups such as Sidebrief managing company formation and compliance across Africa's 54 countries and Norebase creating a single digital infrastructure for every business to start, scale and operate in every African country efficiently being established in 2021 as a direct answer to questions of scale and presence posed by AfCFTA, more traditional companies have not been left out in

seeking to harness the opportunities served up by AfCFTA across Africa.

For example, in July 2021, two of Africa's major logistics companies, Ethiopian Airlines Group and A-E Trade Group, signed a MoU to establish the East African smart logistics and fulfillment hub, committed to the establishment of a business relationship provide end-toend logistics solutions Africa. across Also, AfCFTA-focused some organisations like the AfCFTA Young Entrepreneurs Foundation ,AfYEF, have been formed. This and many other intra-African private partnerships and agreements show that the private sector has been more enthusiastic about the AfCFTA than African governments so far.

Speaking at a webinar organized to mark the launch of the PAFTRAC CEO Trade Survey Report: Assessing the impact of the AfCFTA on African Trade, Talkmore Chidede, Investment expert at the AfCFTA Secretariat said: "Our main priority is to make sure that significant trade starts to happen across the continent under the AfCFTA regime. For trade to happen we have fundamental issues that we have to finalise. In terms of negotiations we have rules of origin, tariff schedules, trade in services commitments and non-tariff barriers".

This sums up the major stumbling block to the AfCFTA's success in Africa. In one way or the other, Africans have always traded with each other, even with the presence of trade barriers like currency, movement and language.

Therefore, if African governments can get over their individual reservations and collectively provide all the policy-related cooperation needed by AfCFTA, then that is the tinderbox needed for the economic integration promised by the AfCFTA become a reality, and in turn better the economic lot of over 1.3 billion Africans.

The governor, who said that he could not and would not play God by being specific on who his successor will be, added that his role is to be fair.

"The South had taken turns to produce a governor in Donald Duke, the Central had also produced a governor in Sen. Liyel Imoke and the North had produced one in me.

"So, it is common sense that we must go back to the South for equity. Every zone should know that their turn would come one day.

"But to be blind and leave it to crude democracy which was not customised to reflect African sensitivity, that if I have had it, and no matter the circumstance, let another too have it," he added.

APC: Hurdles Before Ex-Govs Ahead National Convention

Perhaps the current issue in the polity is the date for the national convention of the ruling All Progressives Congress, APC. The Caretaker and Extraordinary Convention Planning Committee, CECPC, currently managing the affairs of the party under the leadership of Yobe State Governor, Mai Mala Buni, has not been able to conduct the convention since its assumption of office in June 2020.

The caretaker committee came to power after the sack of former Edo State Governor, Adams Oshiomhole and the committee was given the mandate of conducting the party's national convention and as well reconciles aggrieved party members.

The Buni-led team has had its tenure renewed twice. Under his leadership, the APC has no doubt recorded a number of successes including the harvest of three governors including David Umahi, Ebonyi State; Prof. Ben Ayade, Cross River State and Bello Matawalle, Zamfara State.

The defection of the governors was historic. Both Ebonyi and Cross River had been considered a traditional hold of the Peoples Democratic Party, PDP. The case of Zamfara was more like a recovery after it was lost to PDP in 2019 due to internal wrangling within the State chapter of the APC. Mattawale, who was the beneficiary of the APC crisis, got to power through court declaration.

However, the refusal of the APC Buni-led committee to hold its national convention within the stipulated six months it was given generated bad blood among members, many of whom called for his resignation.

Issues bothering on his legality to hold such a high position as a sitting governor soon came up but his backing by the presidency has continued to sustain him in

Last Friday, five aggrieved chieftains of the party from Zamfara State and the Federal Capital Territory including Suleiman Dimas Usman, Muhammed Shehu, Samaila Isahaka, Idris Isah and Audu Emmanuel, approached the Federal High Court sitting in Abuja for an injunction to stop the party from going ahead to conduct its planned national convention.

Reason: They said the party should not hold the exercise because some states, including Anambra and Zamfara, are without state executives. In an affidavit they attached in support of the suit, the Plaintiffs told the court that the party had on October 16, 2020, conducted congresses in only 34 states for the purpose of electing executive committees for the states.

They told the court that no congress was held in both Zamfara and Anambra States, thereby leaving the two states without party executives

Despite the challenges surrounding the feasibility of holding the National Congress of the party and the fact that the party has yet to come up with guidelines for the national chairmanship office scores of party faithful, including former governors, have lined up for the elective office.

Only recently, a group operating under the auspices of Youth Progressives Forum, APCYPF, has endorsed a former governor of Nassarawa State and Senator representing Nassarawa North zone, Umar Tanko Almakura, for the position of national chairman.

"As the 2023 election is fast approaching, the ruling APC must take holistic decisions in the overall interest of its members and Nigerians as a whole by supporting the emergence of Umaru Almakura as the next APC national chairman to stop the party from collapsing after the exit of President

A statement issued recently in Abuja by the National Coordinator of the group, Dr Aliyu Ibrahim, described Akume as a politician with the pedigree to reposition the party.

According to him, this unfolding development is coming ahead of the 2023 Presidential and general elections in which roadmaps are already being laid by party members who understand the dynamics of power-play and balance of power.

"For the APC, sustaining her hold on the political leadership power of government at the three-tiers of governance is the uppermost concern, facing all thoughtprocesses or considerations in the present power equation moves.

"One political leadership figure who understands and applies the principles and laws of political power and deploys the same to good advantage under national group and social dynamics across population sizes, patterns and distributions, is Senator George Akume.

"Ibrahim said that having a strong political personality as Sen. Akume would be a positive gain for the party, given his robust intellectual and administrative experiences.

"His competence, discipline, rich capacity for tolerance and humility in relating with



people irrespective of class, race or religion places Akume as the best candidate to lead the APC", Ibrahim said.

Akume, a two-time governor of Benue State is currently Nigeria's Minister of Special Duties & Inter-Governmental Relations.

A DARK HORSE MAY EMERGE

Similarly, a former National Publicity Secretary of the defunct Congress for Progressive Change ,CPC, and the senator representing Niger East Senatorial District at the National Assembly, Sani Musa, has also received endorsement from some quarters.

While there is no doubt that the trio of Al-Makura, Yari and Akume are serious contenders for the APC national chairmanship, the odds seem to favour Senator Musa.

Apart from having the backing of his State chapter of the party, the lawmaker's bid has also been endorsed by most of the APC senators, who are rooting for one of their own to assume the leadership of the party. Equally working for Musa is the clamour for the chairmanship of the APC to be zoned to the North Central

Those rooting for the senator are of the view that the party should avoid handing its leadership to another former governor given what it went through in the hands of Oshiomhole. According to them, what the ruling party needs going into a general election is a team player as the "Buhari factor" is not going to be there again.

They also insisted that Buni's successor must be a party man and not what they described as "fair-weather politicians", who are known for jumping ship at will. For them, besides being a founding member of the APC, Senator Musa is a highly organised, dedicated, passionate and hardworking person with proven integrity in all the places he has served in both public and private sectors from 1986 to date.

The lawmaker is also described as a great mobilizer, a bridge-builder and a master strategist, who is not only passionate about the wholesome development of the nation but has the capacity required to manage diverse people and interests irrespective of tribe, religion. These, according to them, are what the APC needs going into the 2023 general election.

The belief that Senator Musa, who chairs the Senate Services Committee, is the right for the APC top job, perhaps, explains the various endorsements for his bid.

Just recently, a group under the aegis of APC Stakeholders for 2023 Elections Victory, in declaring support for the senator, said he has experience both at the state, in the business and legislative class to position him well to lead the APC.

Coordinators of the group, Yemi Adeleye and Sabiu Ali, in a statement, described Musa as a grassroots mobilizer and bridge builder, adding: "With the current state of the APC, the party needs to leadership qualities of Senator Musa to continue the reconciliation and peaceful rehabilitation approach that has been entrenched in the party by the Governor Buni-led caretaker committee".

The group said this is the time for the APC to have someone in the capacity of Senator Musa as the APC national chairman to pilot the affairs of the party to victory in 2023 and

He developed and promoted electronic voting for the first time in Nigeria. This manifested in the introduction of Card Reader and Permanent Voters Card, PVC, the revolutionary steps that were instrumental to the transformation of election in the country by INEC in 2015 and 2019.

Whereas the dice of who becomes the party's national chairman is still rolling, stakeholders are concerned about sustaining the recent gains the party has made.

While speaking at an event in Abuja recently, Musa reiterated his resolve and commitment to ensure the unity of the party and as well ensure it remains the ruling party beyond 2023.

"And I believe that whatever it takes to rekindle a society, whatever it takes to rejuvenate a generation, I think I represent that generation and I have what it takes to build on what our previous leaders have done to create what the next Generation can rely

"You are all living Witnesses in this country that all political structures have been reduced to only platforms where leaders usually use to attain leadership. That trajectory is not good for us, It has not given us what is desired. Previous speakers have spoken and it's in tandem with my aspiration that we need a change of direction. We need to reorganize and reposition our party to the level that we can call it an institution.

"If any political historian is here, he will agree with me, looking at the way the narrative is in this country is not different from what has been happening in developing countries like Indonesia where there will be leadership and after just six months of an election, there will be vote of no confidence on that leadership because the leadership cannot attain to given the people their desired aspirations and the dividends of democracy as we call it here and.

"In so doing, if we make our party, an institution where by it will be governed by the books. The trajectory should be that we should have a constitution that will be abided by all. If you're a leader, if you are an aspirant, if you are elected to an office, you should know that there is a book, there is a constitution that we must stand and abide by it. The guidelines of the party are there, the manifesto of the party is there. If you are elected under the platform of this party, there is no way you shouldn't abide by the book that this party has created. Because before you even become a member of this party you must have agreed to the tenets and the ethic of conduct that the party has laid down and this is my aspiration".

He added that he would bring technology to the running of the administration of APC.

"The internal structure needs to be reengineered. We need to re-engineer APC. We need a leadership that is participatory. We need a leadership that is pace setting, we need people with ideas to come in.

"Today, this country, if you look at the generation we have from 18-27 are the majority. What do you have in a pack for them? Are we going to continue with the status quo and believe that once it is done or if I am anointed to be there I will be the one to dictate the tunes? It cannot work anymore. We need to wake up to what Nigerians need; we need to put food on the tables of Nigerians.

"This present administration has started building an ideology for the political parties we are running, that is the APC. Mr. President, everybody can attest to the fact that he is honest, committed and patriotic to this country. So we need leaders that will follow suit. And the legacies that APC is putting forward should not be allowed to be destroyed by anyone and as such you need a party that is very strong. A leader that will be decisive, a leader that will not compromise the office, a leader that does look at worldly things to think that is the best way to go and that is me for you.

"When I said, I would be adaptive to participatory and affirmative work style, which will usher visionary and perfect leadership of this party. Reclaiming Nigeria's Judiciary: An Inconvenient Manifesto

"It is important to move debates about human rights out of courts and legal academies and back to where they belong – in Parliaments and newspapers and among groups of volunteers moved by injustice and cruelty wherever they occur." - Geoffrey Robertson, QC, Bad People and How to be Rid of Them: A Plan B for Human Rights, p. xiv, (2021)

Over the past three weeks, I have addressed various aspects of the multidimensional crisis of both credibility and mission that afflicts Nigeria's judiciary and legal profession. The first article dealt with the crisis of judicial fixation with "political cases" at the expense of providing access to and timely exit from courts for citizens and court users. The second traced the contours of the high-level judicial assault on accountable government, through whimsical decisions that cynically subvert both principle and long-established precedents. The third describes the mechanics of judicial capture, which now characterises the Nigerian judiciary.

I chose the medium of popular platforms for this series because the subject matter is too serious to be abandoned to the cloistered communities of the wig, the gown, the politicians and academic footnotes.

These pieces have been the subject of gratifying debate. Many readers have contacted me to ask that I propose my own counterpoise. Such requests clearly flatter me and, simultaneously, ignore the considerable body of official literature already in existence on these issues within the portals of government. They also imply that the terminal rot of

impunity that afflicts Nigeria's legal and judicial processes at all levels is caused by cognitive limitations, rather than the assurance that whatever happens will attract no consequences.

On December 1993, the government of General Sani Abacha inaugurated the Justice Kayode Eso Judicial Panel for the Reform/ Reorganisation of the Judiciary. After 18 months of work, the panel reported on July 5, 1995 and complained then, nearly 30 years ago, that the military government treated the judiciary as "a mere parastatal of the executive arm of government, a department of the Ministry of Justice", a situation that led them to compromise some judges. The panel recommended 47 judicial officers for termination.

It took another seven years before the report received the attention of the National Judicial Council, NJC, in 2001. The result was the Justice Bolarinwa Babalakin Panel, which built on Kayode Eso Panel's recommendations. Both panel reports ended in considerable controversy over their recommendations for disciplinary action against certain judges. Only six ever got disciplined in the end.

Four years later, in 2006, the United Nations Office of Drug and Crime, UNODC, with the then Chief Justice of Nigeria, CJN, Mohammed Lawal Uwais, undertook and issued a report on the integrity and capacity of the justice system in Nigeria. It found that "political influence in the hiring and promotion of judicial officers, prosecutors and court staff was strongly linked to the perceived quality of justice delivery" and concluded that "[b]oth the perceptions and experience of the quality of justice delivery can be improved by reducing the importance of political connections and enhancing meritocracy in recruitment, hiring, retention, promotion, retirement and the overall management of staff."

This background should make it clear that fighting this rot does not require new proposals. Proposals have long existed and the applicable rules are clear. What is needed is the will to implement them and relocate the system to a place that improves the odds that there will be both consequences for malefaction and incentives for appropriate behaviour. For this, there is no magic bullet. What is clear is that doing nothing is not an option nor is continuing as normal. The Bar, the courts, Senior Advocates and the NJC must urgently find the will to


